<p><b>Purpose of the role</b></p>	<p>The CFH Program Manager role and purpose is to manage the human and financial resources within the CFH suite of programs and to deliver the strategic objectives and milestones for the program. The Program Manager is responsible for recruitment, performance and compliance and has overall accountability for all contracts, service level agreements and/or MOU's.</p> <p>The Program Manager will facilitate the integration between Gateway Health programs to enhance seamless services to clients, consistent with organisational service plan priorities. The Program Manager Child and Family Health is a member of the Senior Management Team and as such plays a role in facilitating information flow and cohesion between all areas of the organisation, with a focus on service coordination and improvement; business development, consumer engagement; planning and monitoring the implementation of strategy; monitoring internal and external environments, participating in relevant external networks and collaboration work; identifying and responding to emerging risks and opportunities; and providing a conduit for information between Gateway Health and external committees / organisations, particularly in relation to Gateway Health's advocacy agenda.</p>

5. Knowledge and experience of Child and Family work and the impacts of trauma.
6. Well-developed communication skills with the capability to prepare reports and correspondence in clear information in a manner appropriate to the purpose and audience.
7. Minimum 3 years' experience within the community, health or welfare sector, or related field

8. Current Australian Drivers Licence or accepted International Drivers licence

9. Confirmation of your right to work in Australia, Satisfactory National/International Police, and Victorian Working with Children Checks must be provided prior to commencement.
